I just found out from a fellow bus rider that they are voting again to decide on whether to keep the 74x. In what world do we live in where "public transportation" is eliminated?

I cannot attend the meeting, but my comments from my January email below remain. I already have to get up at 5:15, to leave my home at 6:15, to get to the 6:30 bus to arrive in time for my work day (because the second bus was eliminated long ago).

It may be thought that we can all just go to Matthews to get the 64x. To get to Matthews in time, I'll lose out on more of my family morning routine. If I have to drive to Matthews, I'll just keep driving to work instead - it's not much further. Parking is about the same as the monthly pass. Paying for gas and parking is the price I will pay for quality of life. And I will arrive home quicker leaving work right at 4:00 instead of waiting an additional 20 minutes for the outbound bus, then having to drive home from Matthews.

The reason I use CATS is for the 74x. I will not be a rider that transitions to 64x. I will stop at grocery stores in Mecklenburg on my way home instead of Union County. I will change my doctors/dentists to folks in Mecklenburg so I can make appointments for offices that are on my way in or out of work if I have to drive.

Also note that I've seen ridership is up, but drivers tend to wave people onto the afternoon bus without paying, which probably makes it appear there are fewer riders.

Eliminating the bus means people won't have any opportunities to use public transportation for work. Is that the goal? Remove employment connections for Charlotte from Union County? Unfortunately, Union County does not have equal pay for similar jobs. I have to work in Charlotte to afford living in Union County. My job in Union County is half the pay as Charlotte.

Hopefully the board makes the right decision for the citizens.

Mr. Hansen.

I never thought a town and county would consider removing a public service such as a bus route. I hope the Board of Commissioners seriously considers the impact this will have should the 74x be cancelled. It may not impact you, or anyone on the board; and you may believe it will only impact a handful of people, however, consider the broader impact. Union County will be cut off from Charlotte for those who rely on public transportation at this time, and in the future. Any plans for the lightrail are too far off in the future to say it will be a replacement for the bus.

I specifically chose to buy a house in Indian Trail due to the Express Bus route. We searched all counties that had Express routes (Gaston, Fort Mill, Concord, Huntersville) and chose Indian Trail. Never did I think a county with an established bus

route would remove it.

Also consider that ridership may be down from pre-covid because the 2nd bus time was removed during the pandemic. Union County used to have 3 bus times. I rode the 2nd bus since 2008, until it was removed. I now arrive at work 20 minutes early because the last bus will cause me to arrive late. Many people may have opted to drive now because they don't want to be 20 minutes early, or late.

This bus is more limited than it used to be, especially with Monroe cut out. What new riders would feel confident making a lifestyle change from driving to riding a bus if they have to fight for the service every year? Or they are not confident it will remain in place?

I subscribe to the Cats emails, and did not know about the impending doom until a fellow rider handed me a printout regarding the meeting. There are many people who are not regular riders who are dropped off and picked up by family/friends, who I doubt know this meeting is taking place. During the summer there are people who walk and ride bikes to pick up this bus. The bus is not only working class cubicle dwellers like myself; who you think can just hop in a car and go to Matthews. It is a means of transportation for many types of people of various income levels.

You may also say I should work in Union County. I would certainly love to eliminate my commute to Charlotte and work closer to home. However, I make <u>double</u> in Charlotte what I would make in Union County, albeit, it is still not enough to afford the gas, wear/tear on my car, and monthly parking. The money I make in Charlotte is brought home and spent here. We don't spend our money in Charlotte. I don't want to pay for their stadium. I shop local, because it never occured to me that my county would not be loyal. If I do have to catch the Matthews bus, I'm not in a mindset after work to drive all the way home to do shopping. I'm mentally worn out from work and I'll do my shopping as soon as I am off the bus in Matthews. This is

something other riders have talked about.

Please pass on my concerns, as I cannot attend a weekday meeting. I have to pick up the kids from aftercare, make dinner, help them with their homework before it's bedtime. My husband and I watched the last meeting via youtube. Everything that was said then by speakers still applies. Nothing has changed except gas prices are up, taxes are increased, and the economy still sucks.
