

## **Amendment 01 to Task Order 8683-02**

This Amendment 01 to Task Order 8683-02 pertains to an Agreement by and between Union County, North Carolina ("OWNER" or "County"), and HDR Engineering, Inc. of the Carolinas ("ENGINEER" or "HDR"), dated January 01, 2024, ("the Agreement"), as modified by Task Order 8683-02 (the "Task Order"). ENGINEER shall perform services on the project described below as provided herein and in the Agreement and Task Order. This Amendment shall not be binding until it has been properly signed by both parties. Upon execution, this Amendment shall supplement the Agreement and the Task Order as it pertains to the project described below.

**TASK ORDER NUMBER:** Amendment 01 to Task Order 8683-02

**PROJECT NAME:** On-Call Hydraulic Modeling Services

The parties agree to amend the Task Order as specified below:

1. Modify **Part 5.0** to increase the total Not-to-Exceed Fee for the Task Order to a total of \$95,700. Payments to HDR shall be based a Per Diem basis, as defined in Section 6.1.3 of the Agreement. Replace the first table in **Part 5.0** of the Task Order with the following:
