AMENDMENT #7

COUNTY OF UNION

This Amendment, made and entered into as of _____, by and between UNION COUNTY, a political subdivision of the State of North Carolina, acting through the Union County Department of Public Health, hereinafter referred to as "Agency," and LIVING GOODNESS, INC., a North Carolina corporation, hereinafter referred to as "Contractor," shall modify as indicated that agreement between the parties dated July 3, 2019, as amended, hereinafter referred to as the "Agreement."

W I T N E S S E T H:

WHEREAS, Contractor currently provides Medical Director services to the Agency pursuant to the Agreement; and

WHEREAS, the Agency now desires to extend the term of the Agreement; and

WHEREAS, the Contractor is willing to continue to provide Medical Director services during the extended term.

NOW, THEREFORE, in consideration of the parties' continuing obligations under the Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto do each contract and agree with the other as follows:

1. The parties hereby agree to renew the Agreement for a term of one (1) year, beginning July 1, 2025, and ending June 30, 2026 (the "Renewal Term"). Upon completion of the Renewal Term, the Agency may, in its sole discretion, elect to renew this Agreement for up to one (1) additional one-year term upon written notice to the Contractor.

2. The parties agree to modify Section 2.a. of the Agreement to increase the Contractor's retainer from Six Hundred Fifty Dollars (\$650) to Seven Hundred Dollars (\$700) per month.

3. The parties agree to modify Section 2.b. of the Agreement to increase the Contractor's hourly rate from One Hundred Fifty Dollars (\$150) to One Hundred Sixty Dollars (\$160).

4. Except as herein amended, the terms and provisions of the Agreement shall remain in full force and effect.

5. Each signatory below warrants that it has the corporate or other organizational power and authority to execute, deliver and perform this Amendment. Each signatory further warrants that the execution, delivery and performance by it of this Amendment and the Agreement has been duly authorized and approved by all requisite action of the party's management and appropriate governing body.
