

AMENDMENT 4 TO THE EMPLOYER/PROVIDER AGREEMENT BETWEEN EVERSIDE
HEALTH, LLC and UNION COUNTY

This Amendment Number 4 (the “Amendment”) is made and entered into as of _____, by and between Union County, a political subdivision of the State of North Carolina (“Employer”), and Everside Health, LLC, a Delaware limited liability company (“Everside”). Everside and Employer may be referred to each individually as a “Party”, or collectively, the “Parties”.

WHEREAS, Everside (or its predecessor) and Employer executed an Employer/Provider Agreement (as amended, the “Agreement”) dated March 24, 2015, pursuant to which Employer engaged Everside (or its predecessor) to provide health clinic and wellness program services for Employer’s health plan participants;

WHEREAS, the Parties amended the Agreement by amendments dated May 9, 2017; November 16, 2017; and July 30, 2021; and

WHEREAS, the Parties wish to amend the Agreement to reflect a new Renewal Term and the associated fees.

THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Parties agree to amend the Agreement as set forth below:

1. The Parties agree this Amendment shall extend the Agreement for a third Renewal Term of three years, commencing on July 1, 2024, and continuing through June 30, 2027. Any Renewal Terms beyond this third Renewal Term shall comply with the current terms of the Agreement.
2. The Direct Fee pricing of \$124 each month for each Adult Patient and \$49 for each month for each Minor Patient shall remain in effect through June 30, 2024. The Direct Fee pricing of \$128.34 each month for each Adult Patient and \$50.72 each month for each Minor Patient shall be the pricing during the first year of the third Renewal Term (July 1, 2024, through June 30, 2025). Thereafter, at the beginning of the second (July 1, 2025, through June 30, 2026) and third (July 1, 2026, through June 30, 2027) years of the third Renewal Term, the Direct Fee pricing, for both Adult Patients and Minor Patients, will automatically increase by three- and one-half percent (3.5%) from the previous year’s fee amounts.
3. The Parties hereby stipulate and agree that unless specifically modified herein, the terms and conditions of the Agreement shall remain in full force and effect.
