NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF UNION COUNTY, NORTH CAROLINA:

<u>Section I.</u> That for the purpose of providing funds, together with any other available funds, for the following projects:

UCPS Capital;

Forest Hills High School East Elementary

Including the replacement of equipment, the acquisition and construction of new facilities, the acquisition and installation of necessary furnishings and equipment and the acquisition of interests in real property required therefore an additional \$2,452,000 is hereby appropriated for a total appropriation of \$149,032,000.

<u>Section II</u>. That it is estimated that the following revenues will be available until completion of these projects to meet the appropriations in Section I, as set forth in the following schedule:

General Obligation Bond Proceeds	\$ 134,405,000
2023 General Obligation Bond Premium	\$ 11,704,446
2023 GO Bond Investment Earnings	\$ 2,452,000
2022 General Obligation 2/3rds Bond Premium	\$ 470,554

<u>Section III</u>. The attached CPO #321B chart is incorporated herein showing appropriations to date, additions as of this capital project ordinance, and the total appropriation.

<u>Section IV</u>. That the finance officer is authorized from time to time to transfer as a loan from the General Fund or unspent County proceeds in the Capital Projects Funds, cash in an amount necessary to meet obligations until such time as financing is arranged, at which time repayment will be made and the finance officer is authorized to sign the Declaration of Official Intent to Reimburse Expenditures as required by Internal Revenue Service regulations.

<u>Section V.</u> That the finance officer is authorized at the time of project completion to close out the capital project and remove it from the general ledger.

<u>Section VI</u>. This capital project ordinance is adopted and effective on this 12th day of August 2024.
