On behalf of the Town of Wingate, this letter serves as a formal request for the Town to assume maintenance responsibility for a portion of **SR #1738** as described below.

- **Beginning:** the intersection of North Main and West Wilson Streets
- **Ending:** the intersection of North Main/Austin Chaney Rd and McIntyre Road
- **Total Length:** 4,136 linear feet

The entire roadway segment described above lies within the corporate limits of the Town of Wingate. Therefore, no County Resolution or Form SR-3 is required.

Enclosed please find the Board of Commissioner Resolution requesting this maintenance transfer and vicinity map clearly showing the limits of the roadway requested for abandonment.

WHEREAS, the Town’s request is in accordance with Chapter 136, Article 3A of the North Carolina General Statutes;


