### MODIFICATION NUMBER 02 TO SUBRECIPIENT GRANT AGREEMENT BEWTEEN UNION COUNTY AND the City of Monroe

This Modification is made and entered into by and between UNION County, ("the COUNTY"), and <u>the City of Monroe</u> ("the SUBRECIPIENT"), to modify FY 2018-19 Community Development Block Grant Contract Number <u>6533</u>, award dated <u>June 11</u>, <u>2020</u> ("the Agreement").

WHEREAS, the COUNTY entered into the Agreement, pursuant to which the COUNTY provided a subrecipient grant award of **FIVE HUNDRED TWENTY THOUSAND DOLLARS AND 00/00 (\$520,000,00)** to the Subrecipient under the Community Development Block Grant Entitlement program (CDBG) as set forth in the Agreement;

WHEREAS, the COUNTY and the SUBRECIPIENT desire to modify the Agreement;

WHEREAS, pursuant to the provisions of Section of the Agreement, which states that the COUNTY or the SUBRECIPEINT may amend the Agreement at any time provided that such amendments make specific reference to the Agreement, are executed in writing and signed by a duly authorized representative of both organizations.

**NOW, THEREFORE**, in consideration of the mutual promises of the parties contained herein, the parties agree as follows:

#### Revise Budget and Allocation

The FY 2018-19 allocation has been increased to EIGHT HUNDRED SEVENTY THOUSAND DOLLARS AND 00/00 (\$870,000), Budget- Section H of the Agreement is hereby deleted and is replaced by the revised Attachment A, Budget section, which is attached hereto and incorporated herein by reference.

All provisions of the Agreement and any attachments thereto in conflict with this Modification shall be and are hereby changed to conform to this Modification, effective as of the date of the execution of this Modification by both parties.

All provisions not in conflict with this Modification remain in full force and effect, and are to be performed at the level specified in the Agreement.
